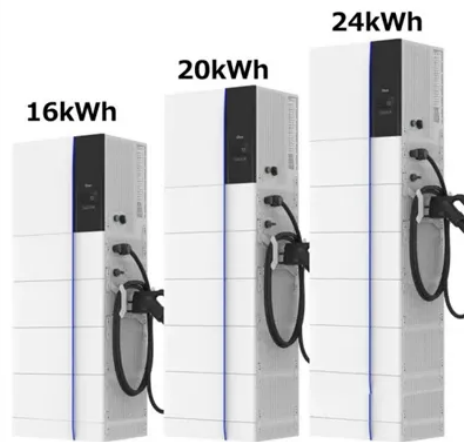




# How to calculate export tax rebate for solar photovoltaic panels



## Overview

You need to have a renewable electricity generating system that meets the SEG eligibility requirements. You must have a meter capable of providing half-hourly export readings. This would typically be a smart meter. Speak to your energy supplier about getting a smart meter installed if you do not already have one. You need to apply directly to a SEG tariff supplier to get paid. The OFGEM website lists the energy suppliers that provide SEG tariffs. Your SEGtariff supplier does not need to be the same as the supplier that provides your energy. Use the Energy Saving Trust calculator to estimate: 1. how much you could save from solar panels or other renewable electricity generating systems 2. how much you could earn selling unused energy back Although you.
